1. CALL TO ORDER AND INTRODUCTIONS

The meeting was called to order at 10:00 AM, on May 8, 2025 by Chair Griffith. A quorum was present.

2. Approve the 566th TTC Meeting Agenda

Chair Griffith asked if there were any questions or changes to the May 8, 2025 TTC Meeting Agenda.

Motion: Approve the May 08, 2025 TTC Meeting Agenda Ms. Bommelman moved, seconded by Mr. Hutchings MOTION, PASSED.

Motion carried unanimously.

3. Approve April 10, 2025 TTC MEETING MINUTES

Chair Griffith asked if there were any questions or changes to the April 10, 2025 TTC Meeting Minutes.

4. Public Comment Opportunity

No public comments were made or received.

5. 2025-2028 Transportation Improvement Program (TIP) Amendment 6

Mr. Bervik presented Amendment 6 regarding the 2025-2028 Transportation Improvement Program (TIP). A public notice was published on Wednesday, April 23, 2025, and comments will be accepted until 12:00 noon on Thursday, May 8, 2025. As of today, no comments have been received.

The proposed amendment to the 2025-2028 TIP is as follows:

- Modification of Project 8250006: MnDOT mill and overlay of Highway 75 from CSAH 12 to 46th Avenue South (2026). Updating the project description. Updated total project cost (-\$320,134 [-20%]) and cost breakdown.
- 2. **New Project 8256051:** MnDOT right-of-way purchase for districtwide snow fence installation local funds. (2026)
- 3. **New Project 8256052:** MnDOT engineering for districtwide snow fence installation local funds. (2026)

- 4. **New Project 8256053:** MnDOT advanced construction for right-of-way purchase for districtwide snow fence installation federal funds. (2027)
- 5. **New Project 8256054:** MnDOT advanced construction for engineering for districtwide snow fence installation federal funds. (2027)
- 6. **New Project 9256055:** NDDOT rehabilitation of railroad crossing and signal radar installation (2025).
- 7. **New Project 9256056:** NDDOT hazard elimination improvements at railroad crossing (2025).
- 8. **New Project 9256057:** NDDOT hazard elimination improvements at railroad crossing (2025).

Motion: Recommend approval of Amendment 6 of the Metro COG 2025-2028 Transportation Improvement Program (TIP) to the Policy Board.

Mr. Gorden moved, seconded by Mr. Steinhoff MOTION, PASSED

Motion carried unanimously.

6. 2025-2026 UPWP Administrative Amendment #1

Mr. Griffith presented information regarding Administrative Amendment #1 of the 2025-2026 UPWP. The dollar amount of the UPWP would only change slightly (\$32.53) due to rounding errors in Excel for staff hours related to program areas, but the total number of hours will remain the same. Staff hours are proposed to be shifted among program areas but no additional hours are being added.

ATAC projects #201 and #205 are intended to be phased, 3-year projects, currently in Year 1 of the 3 years. Project #208, West Metro Perimeter Highway Corridor Study, is currently in a "wait and see" status as Metro COG and the consultant team try to figure out how to proceed due to jurisdictional issues related to currently proposed alternatives. Project funding is proposed to be pulled from this study in order to complete others and to ensure that contractually obligated amounts for all planning projects will be met – keeping in mind that in taking this budget-neutral approach, Metro COG will not require additional funding since no additional CPG funds are expected from NDDOT this year to complete projects. Project completion dates are proposed to be extended to accommodate adequate review times by oversight agencies as well as members of the public.

Mr. Hutchings was concerned about the \$32.53 rounding difference and the amounts not matching up exactly. Mr. Griffith explained it would not affect CPG funding, and that if it did, Metro COG could pull the small amount from locally matched funds.

Motion: Recommend approval of the proposed minor changes to Metro COG's 2025-2026 Unified Planning Work Program to the Policy Board, provided the \$32.53 difference is corrected.

Mr. Hutchings moved, seconded by Mr. Trowbridge MOTION, PASSED

Motion carried unanimously.

Re: Minnesota Federal Functional Classification Update

Metro COG staff have completed a draft of the Federal Functional Classification (FFC) network within the newly updated Adjusted Urbanized Area (AUZA) of the Minnesota portion of the Metropolitan Area. After the completion of the 2020 decennial Census, the Census Bureau released new Urbanized Area Boundaries, which was then adjusted by Metro COG. This necessitated an update to the FFC network. The last update to the Minnesota FFC occurred approximately 10 years ago in 2015. Metro COG has been in coordination with MnDOT regarding these changes.

Staff has worked with local jurisdictions to review and compile a comprehensive list of changes and additions to the FFC system, which is reflected in Attachment 1 (FFC map) and Attachment 2 (FFC table). This update reflects new roadway construction, Adjustments to the Urbanized Area Boundary, roadway closures, and updated Federal Highway Administration (FHWA) Guidance. All proposed changes were made in accordance with The Highway Functional Classification Concepts, Criteria and Procedures (2023), which considers roadway design characteristics such as speed, traffic, shoulders, access spacing, and existing land use.

Additionally, FFC is used to determine eligibility of transportation projects for Federal-Aid. In order to receive federal transportation funding, roadways must be classified as Major Collector or higher.

Federal Highway Administration (FHWA) provides guidance as to the composition of functional classifications within the overall network. **Table 1** listed at the top of the next page contains information regarding Minnesota's portion of our AUZA. Centerline-miles were used to calculate the ratios of each of the following functional classifications:



Re: Review Draft 2026-2027 UPWP & Budget

Each year, Metro COG prepares a two-year Unified Planning Work Program (UPWP) and Budget. NDDOT has been working closely with the four MPOs in North Dakota to develop a timeline for this process.

2026 Budget numbers are estimates from both NDDOT and MnDOT and may be subject to change between now and final adoption in September. 2027 budget numbers are based on the 2026 estimates provided by the State DOTs with an increase of 2% as used by the current transportation bill

One item of note to the TTC members, at some point in the near future, we will need to prioritize the list of potential projects found on page 4 of the Draft UPWP. The projects were not listed in any order and numbers were used for ease of reference (instead of bullet points) since there were so many. I'll discuss this in more detail at the TTC meeting.

Upon approval of the Draft UPWP by the Policy Board, our oversight agencies will review the Draft UPWP and provide comments and feedback. The final UPWP will be reviewed in September. Approval of the Draft 2026-2027 UPWP & Budget begins the process.

Re: 2025-2028 Transportation Improvement Program (TIP) Amendment 7

The Fargo-Moorhead Metropolitan Council of Governments (Metro COG) will hold a public meeting both in person and via Zoom Video Communications on Thursday, July 10, 2025 at 10:00 AM to consider public comments regarding a proposed amendment to the 2025-2028 Transportation Improvement Program (TIP) for the FM Metropolitan Area. The proposed amendment to the 2025-2028 TIP reflects modified federally funded projects within the Metropolitan Planning Area (MPA).

A public notice was published in the Forum of Fargo-Moorhead on Wednesday, June 25, 2025, which advertised the public meeting, detailed how to request more information, and provided information on how to make public comments regarding the proposed amendment. The public notice advertised that public comments will be accepted until 12:00 noon on Thursday, July 10, 2025. As of the writing of this memo, no written comments have been received.

In the last month, local jurisdictions have shifted priorities for several projects in the near term. Below is a narrative of some of the more major changes.

At the Tuesday, May 27, 2025 meeting of the Moorhead City Council, the Council Members approved a request to remove funding from the 2026 STBG 40th Avenue mill and overlay (5250001) and requested to have that 2026 STBG funding be programmed to the City of Moorhead's portion of the pedestrian bridge in the vicinity of the Bluestem Amphitheater.

At the June 9, 2025 meeting of the Fargo City Commission, the Commissioners removed the 45th Street adaptive traffic signal corridor project from their CIP (4250020: 2026 CRP funded).

These changes were presented to the Prioritization Committee, a sub-set of the TTC, to consider the requests and several subsequent changes, primarily to the 2026 funding year. The following page summarizes the unanimous recommendation of the Prioritization Committee for how to proceed with the requested funding changes from the Cities of Moorhead and Fargo, as well as several other smaller changes.

The proposed amendment to the 2025-2028 TIP is as follows:
