**1. CALL TO ORDER AND INTRODUCTIONS**

**3. APPROVE January 14, 2021 TTC MEETING MINUTES**

Chair Gray asked if there were any questions or changes to the January 14, 2021 TTC Meeting Minutes.

**4. Public Comment Opportunity**

No public comments were made or received.

**5. 2021-2024 TIP Amendment #2**

Mr. Champa presented Amendment #2 to the Metro COG 2021-2024 Transportation Improvement Program (TIP).

The proposed amendment to the 2021-2024 TIP is as follows:

1. Modification of Project 9170019: NDDOT concrete pavement repair on I-29N from Main Ave to N Fargo Interchange (2021). The total project cost decreased 68.7% from \$950,000 to \$297,092 of which the Federal IM funding decreased 68.7% from \$855,000 to \$267,383, and the State funding decreased 68.7% from \$95,000 to \$29,709.
2. Modification of Project 9170020: NDDOT concrete pavement repair on I-29S from Main Ave to N Fargo Interchange (2021). The total project cost decreased 68.7% from \$950,000 to \$297,092 of which the Federal IM funding decreased 68.7% from \$855,000 to \$267,383, and the State funding decreased 65.2% from \$95,000 to \$29,709.

The public meeting is scheduled for the February Policy Board meeting (2/18/2021) and has been advertised as such in Metro COG's newspaper of record (Fargo Forum).

This amendment included a revision in language (pages 103-104). The amendment also included the following amendment to the language of the TIP regarding the thresholds for administrative adjustments rather than full amendments. The main purpose of the amendment was to eliminate decreases

in project cost from requiring a full TIP amendment, allowing cost decreases to be handled as administrative adjustments.

**Administrative Adjustment Required:**

1. The increase in total project cost estimate is lower than the TIP amendment thresholds shown in Table 11-1. Justification is required to maintain fiscal constraint;
2. Decrease in total project cost estimate;
3. Change in TIP year. Projects are advanced or deferred within TIP years with no changes to cost or scope. Justification is required to maintain fiscal constraint;
4. The change adds a locally funded project to an existing federally funded project in the TIP if the project cost is greater than \$2,000,000. This applies to both DOT let and local let projects. No action required if the revised total project cost is less than \$2,000,000;
5. The change includes a technical correction;
6. Adding or removing Advance Construction (AC) - includes adding new AC, increase or decrease in existing AC amount (subject to table 11-1 increase threshold), or taking an existing AC off of a project;
7. Removing a project currently programmed in the TIP;
8. Changing FTA funding sources such as changing from Section 5307 funds to Section 5339 funds or vice versa;
9. Changing federal funding from FTA funds to FHWA funds or vice versa. Fiscal constraint justification required;
10. Changing the TIP project number."

**Motion: Recommend approval of Amendment #2 of the Metro COG 2021-2024 Transportation Improvement Program (TIP) to the Policy Board.**

Mr. Altenburg said that the final draft Metro Profile was sent to TTC members on Monday before the meeting, along with the presentation that was given last month, and asked if the committee had any comments.

Ms. Gray asked the committee to reach out at any point with additions or suggestions for the Metro Profile moving forward.

**Motion: Recommend Policy Board approval of the 2020 Metropolitan Profile.**

**7. Fargo Transportation Plan Consultant Selection**

Mr. Maddox presented Kimley Horn (sub-consultant Bolton & Menk) as the selected consulting team for the Fargo Transportation Plan project.

Mr. Solberg asked how the transportation plan ties into Fargo's comprehensive plan. Mr. Maddox said that the plan will update and focus on transportation implementation and visioning.

**Motion: Recommend Policy Board approval of Kimley Horn as the consulting team as recommended by the study's consultant selection panel and recommend Policy Board approval to enter into a contract negotiations for the Fargo Transportation Plan.**

**8. Performance Measures (PM1, PM2, PM3) – 2021 Safety Target Adoption MN & ND**

Mr. Del Rosario presented the Minnesota and North Dakota Performance Measures 1, 2, and 3 for 2021 Safety Target Adoption.

Metro COG staff recommends the adoption of NDDOT's safety targets for Performance Measures 1 and 2, and the adoption of MnDOT's safety targets for Performance Measure 3.

**Motion: Recommend Policy Board adoption of NDDOT's 2021 Safety Performance Measures (PM1, PM2), and MnDOT's PM3 by signing the respective resolutions.**

**Mr. Atkins moved, seconded by Mr. Sahr**

**MOTION, PASSED**

**Motion carried unanimously.**

**9. Draft RFP for Interstate Operations Analysis and Plan for Future Improvements**

Ms. Gray presented the draft RFP for Interstate Operations Analysis and Plan for Future Improvements. The prior analysis was completed in 2011, and is referenced in this RFP. She explained that a meeting was held on Monday, February 8 with a group of engineers who will be involved in the study from MnDOT, NDDOT, Cass and Clay Counties, and the Cities of Fargo, Moorhead and West Fargo. The purpose of the meeting was to discuss the scope of work described in the RFP. The revised RFP was sent out to the TTC on Tuesday, February 9 and contains revisions to a few aspects of the scope of work. Proposals are due March 24, 2021, and the project is budgeted at \$400,000 in the UPWP.

**Motion: Recommend Policy Board approval of the Interstate Operations Study Request for Proposals.**

In January, the Metro COG Policy Board approved the request for proposals (RFP) for the 2021 Fargo-Moorhead Metro Area-Wide Traffic Counts, being led by Metro COG. This project has a budgeted amount of \$130,000 (\$104,000 from Federal CPG funds and \$26,000 from local funds).

The deadline for consulting firms to submit proposals was February 15<sup>th</sup>. Metro COG received proposals from three firms – GHA, The Traffic Group, and Quality Counts. Metro COG and the consultant selection committee met on the Thursday March 4<sup>th</sup> to interview and select one of the three firms.

Upon interviews with the three firms, GHA was the highest ranked firm. GHA's cost proposal came in at \$129,873.96, which is within the project's budgeted amount.

Every five years Metro COG updates the Fargo-Moorhead Metropolitan Bicycle & Pedestrian Plan. This plan takes a comprehensive look at the F-M Metro Area's bicycle & pedestrian networks, seeks input from the public and local jurisdictions, and provides recommendations and guidance to meet the needs of the community and improve the bicycle & pedestrian environment for all users.

The last Bicycle & Pedestrian Plan was completed in 2016 and was completed in-house by Metro COG staff. Metro COG is seeking a qualified consultant to develop an update to the 2016 Plan. The goal is for the updated Plan to be more in-depth than the 2016 Plan with extensive public engagement, planning level cost estimates for future projects, and new ideas to make the F-M Metro Area more safe and accessible for both pedestrians and bicycle users.

**Attached** is the draft RFP for the Fargo-Moorhead Metro Bicycle & Pedestrian Plan Update. The project budget is \$170,000 with \$136,000 (80%) from Federal CPG funds and \$34,000 (20%) from local funds.

## REQUEST FOR PROPOSALS (RFP)

The Fargo-Moorhead Metropolitan Council of Governments (Metro COG) requests proposals from qualified consultants for the following project:

### Fargo-Moorhead Bicycle and Pedestrian Plan Update

Qualifications based selection criteria will be used to analyze proposals from responding consultants. The most qualified candidates may be asked to present a virtually hosted interview. Upon completion of technical ranking and interviews, Metro COG will enter into negotiations with the top ranked firm. **Proposals shall be submitted in PDF format. Sealed cost proposals shall be submitted as a hard copy. Both proposal and cost proposal will be due by the date & time specified below.** The cost proposal of the top ranked firm will be opened during contract negotiations. Those firms not selected for direct negotiations will have their unopened cost proposals returned. Metro COG reserves the right to reject any or all submittals. This project will be funded, in part with federal transportation funds and has a not-to-exceed budget of **\$170,000**.

The full length of each proposal shall not exceed twenty (20) double sided pages for a total of forty (40) pages; including any supporting material, charts, or tables.

## **Fargo-Moorhead Metropolitan Bicycle & Pedestrian Plan Update**

*Note: Throughout this RFP, Metro COG may be referred to as 'Client' and the consulting firm may be referred to as 'Consultant', 'Contractor', or 'Firm'.*

### **I AGENCY OVERVIEW**

The Fargo-Moorhead Metropolitan Council of Governments (Metro COG) serves as the Council of Governments (COG) and Metropolitan Planning Organization (MPO) for the greater Fargo, North Dakota – Moorhead, Minnesota Metropolitan Area. As the designated MPO for the Fargo-Moorhead Metropolitan Area, Metro COG is responsible under federal law for maintaining a continuous, comprehensive, and coordinated transportation planning process.

Metro COG is responsible, in cooperation with the North Dakota and Minnesota Departments of Transportation (NDDOT and MnDOT, respectively) and our local planning partners, for carrying out the metropolitan transportation planning process and other planning needs of a regional nature. Metro COG represents eleven cities and two counties that comprise the Metro COG region in these efforts.

### **II BACKGROUND INFORMATION**

The Fargo-Moorhead Metropolitan Area has a rich history of bicycle & pedestrian planning with known bicycle & pedestrian plans dating back to 1975. The F-M Metro Area also has a history of jurisdictional collaboration on bicycle and pedestrian efforts with the Metropolitan Bicycle & Pedestrian Committee meeting 114 times since its inception.

The Fargo-Moorhead Metropolitan Area has a strong bicycle culture with a nationally-recognized bike share system. In addition the Area has been designated twice by The League of American Bicyclists as a Bronze-level Bicycle Friendly Community. The F-M Metro Area continues to grow and connect both the bicycle and pedestrian infrastructure networks. Shared use paths continue to provide connections, bike lanes and wide paved shoulders provide many of the area's on-street bikeway options, and sidewalks accompanying the vast majority of the urban roadways.

Metro COG and its partnering agencies seek to continue to improve upon past planning efforts in order to make a safe, connected, equitable, and welcoming bicycle and pedestrian experience for all users.

### **III PROJECT OBJECTIVE**

Every five years Metro COG updates the Fargo-Moorhead Metropolitan Bicycle & Pedestrian Plan. This plan takes a comprehensive look at the F-M Metro Area's bicycle & pedestrian networks, seeks input from the public and local jurisdictions, and provides recommendations and guidance to meet the needs of the community and improve the bicycle & pedestrian environment for all users. This plan will incorporate 'The Six E's' of bicycle & pedestrian planning – Education, Encouragement, Evaluation & Planning,

Engineering, Enforcement, and Equity.

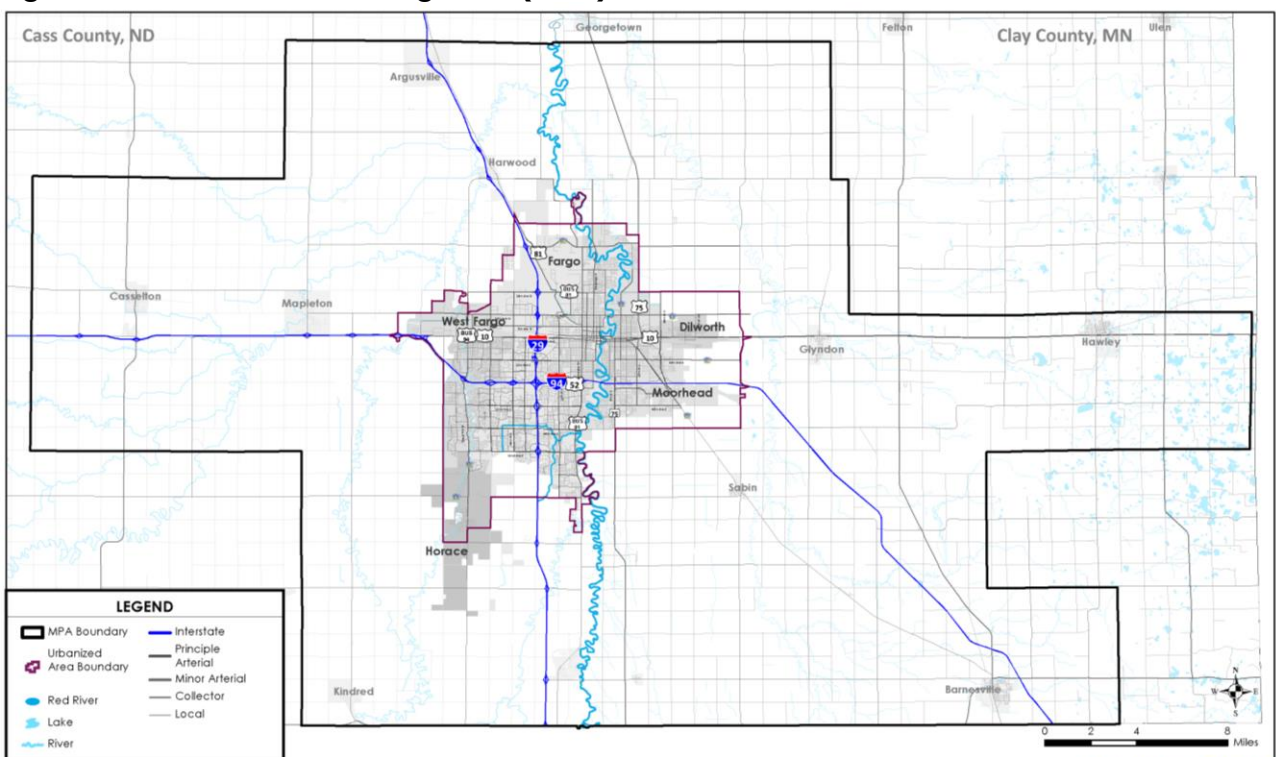
The last Bicycle & Pedestrian Plan was completed in 2016 and was completed in-house by Metro COG staff. Metro COG is seeking a qualified Consultant to develop an update to the 2016 Plan. The goal is for the updated Plan to be more in-depth than the 2016 Plan with extensive public engagement, planning level cost estimates for future projects, and new ideas to make the community more safe and accessible for both pedestrians and bicycle users. The study area for updated Plan will include the entirety of Metro COG's planning area as shown in Figure 1.

**IV SCOPE OF WORK AND PERFORMANCE TASKS**

Outlined below is the scope of work that will guide development of the Fargo-Moorhead Metropolitan Bicycle & Pedestrian Plan Update. Metro COG has included the following scope of work to provide interested Consultants insight into project intent, context, coordination, responsibilities, and other elements to help facilitate proposal development.

This outline is not necessarily all-inclusive. The Consultant may include in the proposal any additional performance tasks or modification of the tasks listed below that will integrate approaches, with special emphasis on the use of innovative techniques, to successfully complete the project.

At minimum, the Consultant is expected to complete the following tasks as part of this project:

**Task 1 – Project Management and Coordination**

The Consultant will be required to manage the study and coordinate with any subconsultants, as well as bearing responsibility for all documentation and equipment needs. The Consultant will identify a project lead from their team to act as the direct point of contact for Metro COG’s project manager.

The Consultant should expect monthly progress meetings with Metro COG, a summary of the meetings shall be prepared by the Consultant. The Consultant should expect other meetings with Metro COG on an as-needed basis. These meetings with Metro COG can occur via phone or video.

Additionally, the Consultant should expect to prepare monthly progress reports, submit adequate documentation of any and all travel and expense receipts, and prepare and submit invoices on a monthly basis. When submitting progress reports, the Consultant will be required to outline the following:

- Performed work during the reporting period
- Upcoming tasks
- Upcoming milestones
- Status of scope and schedule
- Any issues to be aware of

All invoices, travel and expense receipts, and progress reports, are due to Metro COG’s project manager no later than the 2<sup>nd</sup> Thursday of each month. This is to ensure invoices are processed in a timely fashion.

**Task 2 – Data Collection and Existing Conditions**

The Consultant shall gather and analyze relevant existing conditions. Metro COG and its

local jurisdictions will aid in these efforts by providing relevant datasets where they exist. Any other non-existing datasets necessary to accomplish the goals of the analysis will need to be developed by the Consultant. Existing conditions data should include the following (but not limited to):

- Demographics & Travel Trends – The Consultant should provide a summary of the existing local demographics, local demographic trends, local mode-split, and local travel trends.
- Crash analysis – Metro COG can coordinate with the Consultant and local agencies to obtain bicycle & pedestrian crash data. At a minimum this data should contain crash information for the past five years.
- Bicycle network – Metro COG has shapefiles which show the existing bicycle network which include: shared use paths, bike lanes, wide paved shoulders, etc.
- Sidewalk network – Metro COG has shapefiles which show the most up-to-date sidewalk network.
- Bike share network - Metro COG has shapefiles which show the most up-to-date bike share network.
- Bicycle & pedestrian count data – Metro COG has a program which counts bicycle and pedestrian traffic on a regular basis. This data can be provided to the Consultant as part of the existing conditions and analysis.
- Local ordinances – It is encouraged that the Consultant research existing local ordinances as they relate to bicycle and pedestrian modes. These can range from sidewalk construction ordinances to bicycle rules of the road ordinances.

### **Task 3 – Community Engagement**

Community engagement will be in accordance with Metro COG's Public Participation Plan and will involve the following:

#### 1) Study Review Committee Meetings

Development of the Plan will be guided by a Study Review Committee (SRC), which will provide oversight and input into the development of the Plan. The SRC will likely consist of all members of the Metropolitan Bicycle & Pedestrian Committee and will meet on a regular basis throughout the planning process. Meetings will be held virtually, in-person or a hybrid of both depending on the current COVID-19 health crisis situation.

The Consultant should propose the quantity, timing, and content of these meetings. The Consultant will be responsible for coordinating, scheduling, and developing agendas for the SRC meetings. This should be done in coordination with Metro COG's project manager. The Consultant will be expected to distribute materials to the SRC in a timely manner, no less than three business days prior to the meetings. The Consultant is also responsible for the recording of meeting

minutes, which should be submitted to Metro COG's project manager and will serve as documentation of the SRC's guidance and decisions.

### 2) Public Involvement

Public involvement opportunities will be held to obtain input from the community. It is important that public input be gathered from all facets of the Fargo-Moorhead Metropolitan community including but not limited to: all geographical areas, individuals of all ages, genders, races, and income levels. It will be also important to gather input from individuals with disabilities. In addition, this plan should not only be shaped by bicycle or pedestrian advocates, but by the Fargo-Moorhead Metropolitan community as a whole. Extra effort may be necessary to gather input from populations who are not typically represented in bicycle & pedestrian planning efforts.

The Consultant should propose engagement methods they think would be most successful. The Consultant will facilitate all public engagement activities, and should propose the number, type, and strategy for each public involvement effort.

At a minimum, public involvement should include:

- a) Website, Social Media, and Online Survey – Metro COG will host a project website for this study. Metro COG will work with the Consultant in obtaining materials to display on the project website.

As a way to increase public participation, the Consultant should develop online surveys which can be hosted on Metro COG's project webpage and shared via the local jurisdictions', social media, etc.

- b) Public Input Meetings – Whether virtual, in-person, or a hybrid of both, the Consultant should propose an approach to public input meetings during the course of the Plan.

The Consultant will be responsible for providing advertising materials including PDF flyers, media release write-up, and an advertisement for the public notice to be published in the newspaper. All public notice costs will be the responsibility of the Consultant and should be accounted for as part of the project budget.

The Consultant will provide a summary of all public input meetings and, if meetings are held in-person, is responsible for providing materials at the meetings, including but not limited to, sign-in sheets, comment forms, handouts, roll drawings, meeting display boards, and meeting presentations. All public comments received shall be recorded, summarized in the final report or considered for display in the final report's appendix. The Consultant will provide a contact person for

which the public to provide input. The contact person shall be made available by phone, mail and e-mail.

### **Task 4 – Needs, Vision, and Goals**

The Consultant shall work with the SRC and the public in identifying the community's bicycle & pedestrian needs. The Consultant shall then develop a vision and set of goals for meeting the needs. The vision and goals should include 'The Six E's' of bicycle & pedestrian planning – Education, Encouragement, Evaluation & Planning, Engineering, Enforcement, and Equity.

Recommendations from adopted plans should be researched and considered when developing the needs, vision, and goals. These plans should include but not be limited to:

- Minnesota Statewide Pedestrian System Plan (2021)
- Fargo Safe Routes to School Plan (2020)
- Fargo-Moorhead Metro Bikeways Gap Analysis (2019)
- ND Moves – Statewide Active and Public Transportation Plan (2019)
- Fargo Downtown InFocus plan (2018)
- West Fargo Comprehensive Plan - West Fargo 2.0 (2018)
- Minnesota Statewide Bicycle System Plan (2016)
- 2016 Fargo-Moorhead Metropolitan Bicycle & Pedestrian Plan
- Moorhead River Corridor Master Plan (2014)

### **Task 5 – Recommendations**

Based on the needs, vision, and goals as identified in Task 4, the Consultant shall provide a list of recommendations. The recommendations should span 'The Six E's' of bicycle & pedestrian planning and should be vetted by the SRC. The recommendations should be comprehensive and implementable.

### **Task 6 – Implementation**

Per the recommendations outlined in Task 5, an implementation plan shall be developed by the Consultant as a blueprint to meet the needs and achieve the vision and goals. The implementation plan should include prioritization of policies and projects as well as proposed timeframes. In addition, the Consultant should expect to provide planning level cost estimates for, at a minimum, the highest priority projects.

### **Task 7 - Draft Report**

Upon completion of the previous tasks, the Consultant shall provide a draft report for review by the SRC and the public. The report shall include the resulting efforts of Tasks 2 through 6. The draft report should be easy to understand by the public while providing useful information for local decision-makers. Tables, maps, and graphics are encouraged to make the report informative and attractive to users.

The report shall include an executive summary summarizing the key contents in the report. Also, the report shall include an appendix. All meeting summaries, public engagement details, and technical analysis shall be included in the appendix of the report.

**Task 8 - Final Report**

Once comments on the draft report have been received and addressed, the Consultant shall assemble the final report. The final report shall be in PDF format.

**Task 9 – Adoption Process**

As part of the study's adoption process, presentations will be made to local boards and committees. The Consultant should budget for up to four presentations of the final study to local boards and committees.

The presentations will be followed by a question and answer period during which the committee may question the prospective Consultants about their proposed approaches.

Proposals shall be received by **4:30 pm (Central Time) on Wednesday April 14, 2021**. Minority, women-owned and disadvantaged business enterprises are encouraged to participate. Respondents must submit one (1) Adobe Acrobat (.pdf) copy of the proposal. The full length of each proposal should not exceed twenty (20) double sided pages for a total of forty (40) pages; including any supporting material, charts or tables.

**IX GENERAL RFP REQUIREMENTS**

- 1) Sealed Cost Proposal.** All proposals must be clearly identified and marked with the appropriate project name; inclusive of a separately sealed cost proposal per the requirements of this RFP. Cost proposals shall be based on an hourly “not to exceed” amount and shall follow the general format as provided within Exhibit A of this RFP. Metro COG may decide, in its sole discretion, to negotiate a price for the project after the selection committee completes its final ranking. Negotiation will begin with the Consultant identified as the most qualified per requirements of this RFP, as determined in the evaluation/selection process. If Metro COG is unable to negotiate a contract for services negotiations will be terminated and negotiations will begin with the next most qualified Consultant. - 1) The Client reserves the right to reject any or all proposals or to award the contract to the next most qualified firm if the successful firm does not execute a contract within forty-five (45) days after the award of the proposal. - 2) The Client reserves the right to request clarification on any information submitted and additionally reserves the right to request additional information of one (1) or more applicants.

**XIV TERMINATION PROVISIONS**

The Client reserves the right to cancel any contract for cause upon written notice to the Consultant. Cause for cancellation will be documented failure(s) of the Consultant to provide services in the quantity or quality required. Notice of such cancellation will be given with sufficient time to allow for the orderly withdrawal of the Consultant without additional harm to the participants or the Client.

The Client may cancel or reduce the amount of service to be rendered if there is, in the opinion of the Client, a significant increase in local costs; or if there is insufficient state or federal funding available for the service, thereby terminating the contract or reducing the compensation to be paid under the contract. In such event, the Client will notify the Consultant in writing ninety (90) days in advance of the date such actions are to be implemented.

In the event of any termination, the Client shall pay the agreed rate only for services delivered up to the date of termination. The Client has no obligation to the Consultant, of any kind, after the date of termination. Consultant shall deliver all records, equipment and materials to the Client within 24 hours of the date of termination.

**XV LIMITATION ON CONSULTANT**

All reports and pertinent data or materials are the sole property of the Client and its state and federal planning partners and may not be used, reproduced or released in any form without the explicit, written permission of the Client.

The Consultant should expect to have access only to the public reports and public files of local governmental agencies and the Client in preparing the proposal or reports. No compilation, tabulation or analysis of data, definition of opinion, etc., should be anticipated by the Consultant from the agencies, unless volunteered by a responsible official in those agencies.

**XVI CONFLICT OF INTEREST**

No Consultant, Subconsultant, or member of any firm proposed to be employed in the preparation of this proposal shall have a past, ongoing, or potential involvement which could be deemed a conflict of interest under North Dakota Century Code or other law. During the term of this Agreement, the Consultant shall not accept any employment or engage in any consulting work that would create a conflict of interest with the Client or in any way compromise the services to be performed under this agreement. The Consultant shall immediately notify the Client of any and all potential violations of this paragraph upon becoming aware of the potential violation.

The Consultant shall provide evidence of insurance as stated in the contract prior to execution of the contract.

**XVIII RISK MANAGEMENT**

The Consultant agrees to defend, indemnify, and hold harmless the Client and the state of North Dakota, its agencies, officers and employees (State), from and against claims based on the vicarious liability of the Client and the State or its agents, but not against claims based on the Client's and the State's contributory negligence, comparative and/or contributory negligence or fault, sole negligence, or intentional misconduct. The legal defense provided by Consultant to the Client and the State under this provision must be free of any conflicts of interest, even if retention of separate legal counsel for the Client and the State is necessary. Consultant also agrees to defend, indemnify, and hold the Client and the State harmless for all costs, expenses and attorneys' fees incurred if the Client or the State prevails in an action against Consultant in establishing and litigating the indemnification coverage provided herein. This obligation shall continue after the termination of this Agreement.

The Consultant shall secure and keep in force during the term of this agreement, from insurance companies, government self-insurance pools or government self-retention funds authorized to do business in North Dakota, the following insurance coverage:

1. Commercial general liability and automobile liability insurance - minimum limits of liability required are \$250,000 per person and \$1,000,000 per occurrence.
2. Workforce Safety insurance meeting all statutory limits.
3. The Client and the State of North Dakota, its agencies, officers, and employees (State) shall be endorsed as an additional insured on the commercial general liability and automobile liability policies.
4. Said endorsements shall contain a "Waiver of Subrogation" in favor of the Client and the state of North Dakota.
5. The policies and endorsements may not be canceled or modified without thirty (30) days prior written notice to the undersigned Client and the State Risk Management Department.

The Consultant shall furnish a certificate of insurance evidencing the requirements in 1, 3, and 4, above to the Client prior to commencement of this agreement.

The Client and the State reserve the right to obtain complete, certified copies of all required insurance documents, policies, or endorsements at any time. Any attorney who represents the State under this contract must first qualify as and be appointed by the

North Dakota Attorney General as a Special Assistant Attorney General as required under N.D.C.C. Section 54-12-08.

When a portion of the work under the Agreement is sublet, the Consultant shall obtain insurance protection (as outlined above) to provide liability coverage to protect the Consultant, the Client and the State as a result of work undertaken by the Subconsultant. In addition, the Consultant shall ensure that any and all parties performing work under the Agreement are covered by public liability insurance as outlined above. All Subconsultants performing work under the Agreement are required to maintain the same scope of insurance required of the Consultant. The Consultant shall be held responsible for ensuring compliance with those requirements by all Subconsultants.

Consultant's insurance coverage shall be primary (i.e., pay first) as respects any insurance, self-insurance or self-retention maintained by the Client or State. Any insurance, self-insurance or self-retention maintained by the Client or the State shall be excess of the Consultant's insurance and shall not contribute with it. The insolvency or bankruptcy of the insured Consultant shall not release the insurer from payment under the policy, even when such insolvency or bankruptcy prevents the insured Consultant from meeting the retention limit under the policy. Any deductible amount or other obligations under the policy(ies) shall be the sole responsibility of the Consultant. This insurance may be in a policy or policies of insurance, primary and excess, including the so-called umbrella or catastrophe form and be placed with insurers rated "A-" or better by A.M. Best Company, Inc. The Client and the State will be indemnified, saved, and held harmless to the full extent of any coverage actually secured by the Consultant in excess of the minimum requirements set forth above.

## Federal Clauses

### Equal Employment Opportunity Clause – 41 CFR 60-1.4(a) and 2 CFR Part 200 Appendix II (C)

#### 41 CFR 60-1.4(a)

- (a) *Government contracts.* Except as otherwise provided, each contracting agency shall include the following equal opportunity clause contained in section 202 of the order in each of its Government contracts (and modifications thereof if not included in the original contract):during the performance of this contract, the contractor agrees as follows:
- (1) The contractor will not discriminate against any employee or applicant for employment because of race, color, religion, sex, or national origin. The contractor will take affirmative action to ensure that applicants are employed, and that employees are treated during employment, without regard to their race, color, religion, sex, or national origin. Such action shall include, but not be limited to the following: employment, upgrading, demotion, or transfer, recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship. The contractor agrees to post in conspicuous places, available to employees and applicants for employment, notices to be provided by the contracting officer setting forth the provisions of this nondiscrimination clause.
  - (2) The contractor will, in all solicitations or advertisements for employees placed by or on behalf of the contractor, state that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, or national origin.
  - (3) The contractor will send to each labor union or representative of workers with which he has a collective bargaining agreement or other contract or understanding, a notice to be provided by the agency contracting officer, advising the labor union or workers' representative of the contractor's commitments under section 202 of Executive Order 11246 of September 24, 1965, and shall post copies of the notice in conspicuous places available to employees and applicants for employment.
  - (4) The contractor will comply with all provisions of Executive Order 11246 of September 24, 1965, and of the rules, regulations, and relevant orders of the secretary of labor.
  - (5) The contractor will furnish all information and reports required by Executive Order 11246 of September 24, 1965, and by the rules, regulations, and orders of the secretary of labor, or pursuant thereto, and will permit access to his books, records, and accounts by the contracting agency and the secretary of labor for purposes of investigation to ascertain compliance with such rules, regulations, and orders.
  - (6) In the event of the contractor's non-compliance with the nondiscrimination clauses of this contract or with any of such rules, regulations, or orders, this contract may be canceled, terminated or suspended in whole or in part and the contractor may be declared ineligible for further government contracts in accordance with procedures authorized in Executive Order 11246 of September 24, 1965, and such other sanctions may be imposed and remedies invoked as provided in Executive Order 11246 of September 24, 1965, or by rule, regulation, or order of the secretary of labor, or as otherwise provided by law.

- (7) The contractor will include the provisions of paragraphs (1) through (7) in every subcontract or purchase order unless exempted by rules, regulations, or orders of the secretary of labor issued pursuant to section 204 of Executive Order 11246 of September 24, 1965, so that such provisions will be binding upon each subcontractor or vendor. The contractor will take such action with respect to any subcontract or purchase order as may be directed by the secretary of labor as a means of enforcing such provisions including sanctions for noncompliance: *provided, however*, that in the event the contractor becomes involved in, or is threatened with, litigation with a subcontractor or vendor as a result of such direction, the contractor may request the united states to enter into such litigation to protect the interests of the United States.

### **2 CFR Part 200 Appendix II (C)**

- (C) Equal Employment Opportunity. The Fargo-Moorhead Metropolitan Council of Governments (Metro COG) will hold a virtual public hearing via Zoom Video Communications on Thursday, March 18, 2021 at 4:00 p.m. to consider public comments regarding a proposed amendment to the 2021-2024 Transportation Improvement Program (TIP) for the FM Metropolitan Area. The proposed amendment to the 2021-2024 TIP reflects updated and new federally funded projects within the Metropolitan Planning Area (MPA) and changes to the TIP document text.

A public notice was published in the Forum of Fargo-Moorhead on Wednesday, March 3, 2021, advertising the public hearing, how to request more information, and detailed public comment information such as where to send written comments regarding the proposed amendment. The public notice advertised that public comments will be accepted until 12:00 p.m. (noon) on Thursday, March 18, 2021. As of the writing of this memo, no written comments have been received.

The proposed amendment to the 2021-2024 TIP is as follows:

1. **Addition of Project 8213004:** West Central Communities Action, Inc. project for mobility management (2021). The total project cost is \$56,700 of which \$45,360 (80%) if funded through Federal Section 5310, \$5,670 (10%) through State funds, and \$5,670 (10%) through local funds.
2. **Addition of Project 4213005:** Fargo Transit project for phase 2 of the Ground Transportation Center (GTC) renovation, renovation of the building exterior (2021). The total project cost is \$2,148,024 of which \$1,798,024 (83.7%) if funded through Coronavirus Aid, Relief, and Economic Security (CARES) Act funding apportioned to the Federal Transit Administration (FTA) for urban areas, \$280,000 (13%) through Federal Section 5339 funds, and \$70,000 (3.3%) through local funds.
3. **Modification of Project 4190003:** City of Fargo project for the reconstruction of 32<sup>nd</sup> Ave S (2021). The total project cost remains \$10,400,000 of which the Federal Surface Transportation Block Grant Program – Urban (STBGP-U) funds remain \$4,700,000 (45.2%), the addition of \$808,620 in Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) funds apportioned to the State of North Dakota and distributed through the County and Urban Roads programs, and local funds decreased 14.2% from \$5,700,000 to \$4,891,380.

4. **Addition of Lump Sum Projects:** Lump sums are being included for fiscal year 2021 for three phases: Preliminary Engineering (PE) (project 9213006), Right-of-Way (ROW) (project 9213007), and Utilities (project 9213008). Lump sums are shown for all North Dakota projects in the MPO boundaries that have not had the project phase already authorized. Some projects may not be in a bid opening until 2024 but phases of project authorizations could be made in 2021. Lump sums include various projects which encompass various federal funding programs and various local funding sources.

PE lump sum total cost is \$2,402,000 of which \$1,943,000 is funded through Federal funds, \$227,000 through State funds, and \$232,000 through local funds.

ROW lump sum total cost is \$4,000 of which \$3,000 is funded through Federal funds, and \$1,000 through State funds.

Utilities lump sum total cost is \$4,000 of which \$3,000 is funded through Federal funds and \$1,000 through State funds.

5. **Text modifications (pages 10-11 and 26-27):** In coordination with NDDOT, Metro COG is proposing a revision to the Regionally Significant Project definition within the TIP document. The goal of this change is to refine the definition so as to limit the number of projects that will be defined as Regionally Significant moving forward. Unforeseen repercussions of defining projects as regionally significant has been felt in the federal funding authorization process. The new direction will require that Regionally Significant projects and individual regionally significant project phases be tracked more thoroughly (separately), something that Metro COG, the other MPOs in North Dakota, and NDDOT were not doing up to this point. The new definition of Regionally Significant Projects will help smooth out the federal funding authorization process for projects within the TIP/STIP and continue to improve coordination efforts between Metro COG, NDDOT, and FHWA-ND. Please see below for the tracked changes to the Regionally Significant Projects text as found within the TIP:

#### **Pages 10-11**

**“Regionally Significant Project:** A Regionally Significant Project (RSP) is defined as follows:

1. A highway project consisting of the construction of a new interstate interchange, adding interstate through-lane capacity; or
2. Creating new roadways on new right-of-way, both financed with federal funds, which do not consist of an extension of the existing urban roadway network resulting from urban expansion; or

3. Creating a new transit building on newly purchased real estate.

### **Pages 26-27**

#### **"Regionally Significant Projects**

A Regionally Significant Project (RSP) is defined as follows:

1. A highway project consisting of the construction of a new interstate interchange, adding interstate through-lane capacity; or
2. Creating new roadways on new right-of-way, both financed with federal funds, which do not consist of an extension of the existing urban roadway network resulting from urban expansion; or
3. Creating a new transit building on newly purchased real estate.

All projects identified as RSPs appear within the project listings of the TIP document, and are denoted accordingly as being "RSP." RSPs have been identified within the MPA as defined above. In addition, RSPs shall have all project phases broken out by fiscal year and may not be included in the Lump Sum project tables. RSPs also need to be included in the financial plan and fiscal constraint section of the TIP, included in the STIP, and are subject to formal TIP and STIP modification procedures at the Metro COG and State level, respectively."
