1a. Approve Order and Contents of the Overall Agenda

Chair White noted that one of the items listed under "Informational Only" was not appropriate for that section. She referenced the Interim Joint Powers Agreement, which states that any budget-related items must be recommended for approval by the Board before being forwarded to a partner city. She suggested moving Item 2a and incorporating it into Item 3b under the "Action Items" section.

A motion to approve the order and contents of the agenda as amended was made by Mr. Mastera and seconded by Mr. Griffith. The motion was voted on and unanimously approved.

1b. Review and Action on Minutes from July 16, 2025

A motion to approve the minutes for July 2025 was made by Mr. Griffith and seconded by Mr. McDougall. The motion was voted on and unanimously approved.

2b. Safety and Security Update

Mr. Swingen provided an update on safety and security, noting that many of the same concerns previously identified continue to persist.

Chair White inquired whether MATBUS has experienced an uptick in crime following the closure of the Downtown Engagement Center. Mr. Swingen responded that it is difficult to draw a direct correlation between the two and noted that some of the ongoing issues appear to stem from a few recurring individuals.

3a. City of Fargo Transit Title VI Civil Rights Program

Mr. Crowell presented an update on the Title VI Plan, noting that the plan is required to be updated every three years. He explained that, following board review, the plan will proceed to the Fargo City Commission, and ultimately to the Federal Transit Administration (FTA) for final approval.

Mr. Crowell clarified that the materials included in the meeting packets are only a summary of the Title VI Plan. The full document, which is approximately 500 to 600 pages, will be submitted to the Fargo City Commission as part of the approval process.

A motion to authorize staff to bring the proposed City of Fargo Transit Title VI Civil Rights Program to the Fargo City Commission for approval and submit to the Federal Transit Administration was made by Mr. Griffith and seconded by Ms. Bommelman. The motion was voted on and unanimously approved.

2a & 3b. 2026 Proposed City of Fargo and City of Moorhead Transit Budgets & Proposed Route and Service Changes in Fargo and West Fargo

Ms. Bommelman began by noting that, due to the ongoing rise in operational costs and the stagnation of revenue streams, MATBUS was proposing route changes in Fargo and West Fargo. She stated that MATBUS had done extensive research to ensure the proposed changes affected the smallest number of riders. She noted that a public hearing on route changes would be held during the Fargo City Commission meeting on September 2 and that an open house would be held at the GTC on August 25 from 4:00 to 6:00 PM.

A description of some of the proposed changes included:

- Route 13: The proposed change would reduce the frequency of Route 13. Route 13 would only depart the Ground Transportation Center at :15 after the hour. Currently Route 13 departs at :15 and :45 after the hour from 6:15 AM to 5:45 PM Monday through Friday.
- Route 14: The proposed change would reduce the frequency of Route 14. Route 14 would only depart the Ground Transportation Center at :45 after the hour. Currently Route 14 departs at :15 and :45 after the hour from 6:15 AM to 5:45 PM.
- **Route 15:** The proposed change would increase Route 15 from a 60-minute route to a 90-minute route to improve on-time performance. A pilot program of this change was introduced in May of 2025 to determine the effectiveness of this change.
- **Route 16:** The proposed change would eliminate Route 16 (Transit staff discussed this proposed change with the Fargo Housing Authority; with Route 14 servicing 4th Street going past the old High Rise, there were no concerns about serving the new public housing at the same location.)
- **Route 18:** The proposed change would reduce Route 18 from a 90-minute route to a 60-minute route. Route 18 would end at the Essentia Health clinic on 32nd Avenue

S, and would no longer service any areas south of 32nd Avenue S. The northern portion of the route would also be adjusted to service the Cass County Jail and surrounding areas.

- Route 20: The proposed change would reduce Route 20 from a 60-minute route to a 30-minute route. Route 20 would only travel as far east as 42nd Street S. This would eliminate service to the Cass County Jail and surrounding areas.
- West Acres Transit Hub: The proposed change is to no longer utilize the West Acres Transit Hub as a transfer point for MATBUS routes. Instead, transfers would be made at the Walmart bus shelter, located at the intersection of 47th Street S and 11th Avenue S. This change would affect Route 14, Route 15, Route 20, and Route 24 (as well as Route 16 if it is not eliminated).
- Industrial Park On-Demand Service: The proposed change would eliminate the Industrial Park On-Demand Service.
- **Paratransit Service:** The proposed change would eliminate Sunday Paratransit services. Currently, MAT Paratransit operates from 7:00 AM to 5:00 PM on Sundays.

Following the presentation of proposed route changes, Mr. Swingen provided the committee information on MATBUS's full 2026 budget with and without proposed reductions. Mr. Swingen and Ms. Bommelman noted that full 2026 expenses prior to revenue being applied for MATBUS were \$15,979,075.33. Mr. Swingen shared that, after revenues are applied, expenses were \$5,001,789.20 for the City of Fargo, \$4,262,210.87 for the City of Moorhead, \$444,960.28 for the City of West Fargo, and \$805,263.54 for NDSU. Total expenses after revenues are applied were \$10,514,223.89.

Mr. Swinged compared the prior information with a 2026 budget that included proposed reductions to Fargo and West Fargo service. Total expenses prior to revenue being applied were \$14,606,703.42. After revenues are applied, expenses were \$3,310.575.12 for the City of Fargo, \$4,319,901.79 for the City of Moorhead, \$461,292.26 for the City of West Fargo, and \$756,230.06 for NDSU. With this scenario, total expenses after revenues are applied were \$8,847,999.23

Chair White noted that, under the 2026 budget with proposed route and service changes in North Dakota, the City of Moorhead's expenses were actually more, without any additional benefits to its residents. Mr. Swingen explained that this had to do with the redistributions through the cost allocation formula and noting that Moorhead would have a higher percentage of service. Chair White asked whether MATBUS was looking at riders and where they originated, or where the routes were. Mr. Swingen responded that the cost allocation formula, as currently modeled, only looks at the cities where routes are located, regardless of which metro area city's residents utilize it the most. He iterated that MATBUS is trying to impact the overall transit system as minimally as possible by looking at low ridership routes and ways that MATBUS can adjust existing routes.

Chair White voiced her concerns that, because of financial difficulties with the City of Fargo, all of the MATBUS partners will be impacted, and the City of Moorhead would be paying a higher share of expenses for lower overall quality service. Mr. Smith confirmed Chair White's concerns but noted that the cost allocation formula was working as it was intended to.

Chair White asked what involvement the other partners (Moorhead, West Fargo, Dilworth, and NDSU) had in any of the budgetary discussions between MATBUS and the City of Fargo. Ms. Bommelman responded that there had been discussions with the City of Moorhead at times throughout the process. Ms. Flanagan and Ms. Zahradka expressed concerns that

they did not have a clear picture of the proposed route and system changes and their implications.

Ms. Kolpack left at 9:39 AM.

Chair White said that, speaking as a Moorhead resident, it was disturbing to see that expenses for the City of Fargo were unilaterally reduced by approximately \$1.7 million while being increased for the City of Moorhead, and that the detriments would be felt system wide. She reiterated that the City of Moorhead and others were not being treated as equal partners in the budgetary discussions between City of Fargo staff and MATBUS. She also expressed concern that the transit budget agenda item was initially listed as an informational item when the MATBUS Coordination Committee is required to hold a vote prior to sending budgets to the Fargo City Commission and Moorhead City Council.

Mr. Strand stated that the views of the committee needed to be communicated clearly to the City of Fargo, both staff and elected officials. He also recommended that the partners convene immediately and discuss budgetary and system changes jointly. Chair White responded that she had expressed her concerns repeatedly at prior committee meetings and that joint meetings between the partners should have occurred months ago. She stated that she and other committee members did not have to support a budget that they had no part in.

Ms. Thompson asked what the next steps should be regarding a discussion between MATBUS and its partners, and whether the committee should meet prior to its scheduled meeting on September 17. Ms. Flanagan iterated that it was important for the partners to begin discussions as soon as possible. With regard to the City of Fargo's upcoming public hearings and budgetary discussions, Mr. Rietz asked that no action be taken on MATBUS' budget until the partners have had a chance to discuss issues further. Chair White suggested a special meeting of the MATBUS Coordination Committee on September 10.

A motion to oppose the 2026 proposed City of Fargo and City of Moorhead transit budgets and proposed route and service changes in Fargo and West Fargo until further evaluation and discussion was made by Mr. Rietz and seconded by Mr. Strand. Mr. Mastera offered a friendly amendment to include the creation of a working group comprised of partner agencies to continue budgetary discussions, which was accepted by the maker and seconder. The amended motion was voted on and unanimously approved.

3. Other Business

Ms. Bommelman and Mr. Altenburg gave a brief update on the MATBUS Transit Development Plan. They noted that the draft final plan was released on July 30 and that a public comment period was open until September 10. They also informed the committee that a virtual public open house was scheduled for August 27 from 11:00 AM to 1:00 PM.

Chair White reminded the committee that a special meeting of the MATBUS Coordination Committee would be held on Wednesday, September 10 at 9:00 AM.

Chair White adjourned the meeting at 10:10 AM.




Comment Overview


West Acres & Industrial Park Service

West Acres Transit Hub: The proposed change is to no longer utilize the West Acres Transit Hub as a transfer point for MATBUS routes, instead, transfers would be made at the Walmart bus shelter, located at the intersection of 47th St S and 11th Ave S. This change would affect Routes 14, 15, 20 and 24 (as well as Route 16 if it is not eliminated). The cost for a year to lease and provide security services is approximately \$175,000; a portion of the existing costs could potentially be necessary at the proposed location (Walmart), resulting in a lower cost savings.


Industrial Park On-Demand (TapRide) Service: The proposed change would eliminate the Industrial Park On-Demand Service. The number of trips per day on this service is approximately 10-12 riders. Please note the nature of the businesses in the Industrial Park is shift work, Transit may be able to bring someone to work or pick them up after work, but likely not both.




Paratransit Sunday Service



Complimentary Paratransit Service: The proposed change would eliminate Sunday Paratransit services. Currently, MAT Paratransit operates from 7:00am to 5:00pm on Sundays and transports 10-12 riders per Sunday. Complementary paratransit services are federally required during the same hours fixed route service operates. Fixed Route service does not operate on Sundays; therefore, this service is offered above and beyond what is required of the City/Department.

Subject: Public Hearing Communication and Comments

MATBUS staff have proposed several changes to routes and services, in an effort to balance the department's 2026 budget. These proposed changes would go into effect on January 1, 2026, if approved.

MATBUS policy directs that staff must solicit and consider public comment for implementation of all changes in fares or major changes in service. As part of this process, there was a public hearing held during the Fargo City Commission meeting on Tuesday, September 2, 2025. During this public hearing, members of the public were welcome to present their comments in person, verbally, to Commission members.

The public was also invited to register their comments prior to the public hearing, and those comments were presented to the Commission members for their consideration. These public comments could be made by email, phone call, social media comment or direct message, paper comment cards, or the online public comment map.

Efforts to inform the public of this hearing and potential changes are described below:

- Public Hearing Notices formal notices placed in The Forum on August 17 and 22, describing changes in detail – one for route changes and one for fare changes in each edition
- Public Comment Map online map of the fixed route system, showing all proposed changes – public can add comments by dropping pins on specific sections of the map
- Rider Alerts email blasts sent to 1,802 people on our subscriber list
- **Bus Posters** placed in all 43 fixed route vehicles, with QR codes linking to detailed information and the public comment map
- **GTC Display** details posted in the GTC display case, with comment sheets available to be filled out by hand and turned in to the Customer Care window

- Social Media announcements and reminders posted on Facebook, X and Instagram
- MATBUS Website News Post full details posted with a link to the public comment map
- MATBUS Website Homepage Rotator image in the rotating homepage carousel that links to the news post
- **GTC Display Screens** TV screens in the GTC lobby that display rotating information
- Paratransit Rider Direct Mailing sent to every rider in the MAT Paratransit system, including both public hearing notices (one for route changes, one for fare changes) and an explanatory cover letter

Every person who uses public transit means there is more room for drivers on the road. They decrease traffic, save wear and tear on the city's streets, and leave more parking spaces available.

A few months ago, the Forum reported that the 2024 ridership on MATBUS was up to 1.3 million riders: a lot of extra traffic that every Fargo-Moorhead driver would have to contend with and compete with for parking spaces. Anyone riding public transportation is providing a benefit to the city, not to mention helping the environment as a bonus. It often seems, however, that bus riders are instead viewed by the city as a burden or, at best, undeserving charity cases.

As another Forum article noted in March, the system "has seen its funding cut as it also grows," and sadly, that trend is continuing with the latest proposed changes, at least two of which will make the system much more difficult to use.

Route 15 has historically been one of the busiest, most efficient routes, running between downtown, West Acres, and Walmart every 15 minutes during the week, and every half hour on weekends, allowing people to get to businesses on

or near 13th Avenue, from eye appointments to Christmas shopping to visiting the bank. The only problem with it was that the bus was so packed on Saturdays, I always thought they should run every 15 minutes then too. The "pilot project" ahead of the planned permanent change does the opposite, running only once an hour on Saturday mornings. This has made the route much harder to use, adding an hour to my quick errands (from an average of one hour to two).

Even more startling is the elimination of the West Acres Transit Hub, which, in the announcement, doesn't make clear until the fine print that it will save time by not going to West Acres at all. I can't believe the city is planning to remove this major destination from the route, since I've personally been taking the bus to West Acres since I was in college in 1985. Not only do people need to get to their jobs, obviously a benefit to the community, but their ability to shop helps the economy. Even worse is moving bus riders from an enclosed, decent-sized and well-lit space, protected from the elements and with enough people around for security, to an open, unprotected and obviously less secure shelter stuck on a corner between big box stores. When buses only run once an hour, that increases the likelihood that people will need to wait longer periods, and with winter coming, this is a big problem.

Many people just can't use the bus if it takes two hours: they have to get to work, get their kids to school, get to appointments and not have to wait in the cold. All of these changes feel like the mode of popular planning which starves a service of resources in order to destroy it: if a service is made inconvenient and difficult enough, fewer people will be able to use it, and then the reduced use is taken as justification for the lack of service. Making life exponentially difficult for the residents and tax-payers who rely on the city bus system.

The elimination of the south half of Route 18 will strand me and many others. I will not be able to get to and from work, medical appointments, shopping, or any other parts of Fargo-Moorhead. If this change goes into effect, I will be forced to find other transportation and would no longer be able to use MATBus services.

This is *not* a threat that I will willingly stop using MATBus if the changes go into effect; it is a statement of fact. If I wanted to continue using MATBus, I would need to walk nearly an hour to and from the nearest bus stop. This is out of the question for even the healthiest person in fair weather, not even considering the typical inclement weather Fargo-Moorhead receives. My daily commute sees many regular riders on the southern half of Route 18 who will also have to seek other transportation services, further reducing MATBus revenue.

Previous proposed changes to routes/service never suggested that this area of Fargo would no longer have service. I was willing to add a third route to my daily commute. I am willing to pay more in bus fare for this sole route to South Fargo to remain.

I know Route 18 isn't the most passenger-heavy route because it is a very long ride from downtown, and if coming or going south of Essenia, you have to wait an hour before another bus comes in the direction you are going. However, people such as myself depend on it for our livelihoods and shopping. Without the current Route 18, I wouldn't be able to go to work or do my shopping afterward. I personally know a woman who lives in the senior housing next to Hornbachers who works at Walmart on 52nd. This bus is the only means she has to get to work and do her shopping. She relies on Route 18 100%.

Were this proposed reduction of service to take place, I honestly don't know what to do if MAT Bus decided not to serve that part of town anymore. I can't afford to quit my job, and daily Uber or taxi rides wouldn't be feasible. That woman at the senior housing, who can barely afford that, may end up in much worse circumstances if she isn't able to beg for a ride from a kind soul just to get to and from work every day.

I implore you, please don't stop service to the area south of Essenia. Even if you had to reduce service to one bus at 90 minute service, it would be better than no bus at all, or if you could offer a ride-on-demand service like you do for the Industrial Park and NDSU. Like that woman in senior housing, I know of other workers who rely on Route 18 to get to work at Swanson Health, Aldevron, Hornbacher's at Osgood, Walmart at 52nd and even Microsoft who need this service to get them to and from work, even on a temporary basis.

I know the Federal and State cuts are devastating everyone (and technically for no good reason - we all know the ultra rich don't need tax cuts). We have to find a way to work together in spite of them. We are more powerful together.

As I will be unable to attend tonight's commission meeting, I wanted to be sure my voice was heard in regard to the matter of the MATBUS proposal in regards to cutting certain services.

I have already written a letter to the MATBUS transit email, but over the weekend, I was able to view the August 20 MATBUS coordination committee meeting and look at the agenda documentation. Hearing from the Moorhead financial officers gave me an additional perspective to view the changes from, and that is what I would like to address here.

The financial impact of the cuts in service to the whole of the Fargo-Moorhead area will be immense. My main concern personally is Route 18 because it is the bus I use to get me to and from work. According to the materials shared for the August 20 meeting, the number of riders impacted if Route 18 alone was truncated at Essenia is 117. That is likely 117 people out of a job if Route 18 were changed to the proposed cuts.

Another proposed change is to make Walmart the transfer point rather than West Acres. The number of people impacted there are just shy of 1000. I did not see what the proposal was in regard to West Acres, but I did hear at the coordination meeting that there is difficulty getting in and out of the West Acres parking lot. I, too, have noticed that this is a congested area, and since the move by Best Buy to that end of West Acres, the task of getting in and out of the bus area is far more difficult since buses have to compete with Best Buy customer traffic.

How will the people who work and shop at West Acres get to and from the bus and West Acres? What is the proposal to address this? The current area for the buses is inadequate, it is true, plus all the traffic congestion makes things more difficult to get in and out on time. I would personally like to see more ideas and proposals about what to do with this. I know other plans had been in the works about a new bus area, but none of that was included here. Were those plans scrapped, and why? What new plans for addressing getting these 1000 regular passengers to and from the area are being proposed, since it is so problematic?

I do not feel that these proposed changes have taken in the financial impacts of the community. This proposal is very drastic, and it feels like it was also very sudden. I know there are issues about federal and state funding that has caused this sudden proposal, but I don't feel this proposal is the best way of handling them. Cuts are not always the solution.

I am sending this email both to John Strand with the Fargo City Commission as well as the MATBUS transit email to ensure that this is included in tonight's meeting, as I will be at work and unable to attend. I will also include the ridership impact page from the August 20 coordination committee meeting.

Thank you for the service you all provide to our community. Although we don't say it enough, we do appreciate the effort your service provides to us. Thank you.

Hello,

I am writing to express concerns about the planned service changes for 2026. I have been a daily rider of MATBUS for more than 10 years. I have worked two jobs for the past decade, and MATBUS transportation is what allows me to make this work.

I selected the location of my current residence off Fourth Street in part because it is along Route 14 and Route 16. The changes proposed for these two routes would drastically affect my ability to function as I currently do. I take the first Route 14 bus of the day at 6:15 am because it gets me to my full-time job in the West Acres area before my starting time. If Route 14 did not depart until 6:45 am, I would not arrive on time to work my current schedule. Route 16 would be the only other option for an on-time arrival, but that bus is slated for elimination.

Route 16 is also the bus that takes me home from work and delivers me to my part-time job downtown, which I work on Saturdays and some weekday evenings shortly after my other job. If Route 16 is eliminated, I will have no option for an inbound bus to downtown. This is of particular concern during inclement weather, especially dangerous cold in winter. Route 16 is also my link to the GTC for transfers to other buses.

Besides getting to my places of employment, I use MATBUS multiple times a week for grocery shopping. Route 16 is the only bus with a designated stop at the Fargo CashWise store, which I can now access immediately after work from West Acres. I understand that a Route 15 stop is nearby, but that bus does not get me as close to home and would require a multiple-block walk home with a load of groceries to carry.

I hope you will consider keeping Route 16 service. Also, if Route 14 needs to be reduced to once per hour, I would ask that you consider maintaining a start time of :15 after the hour to accommodate people who need an earliest possible bus. In addition, I was wondering if you have considered the feasibility of re-routing Route 14 so that the inbound bus could run north on Fourth Street. Doing so would at least provide an inbound option if Route 16 is eliminated.

Fargo might not be the home I was born into, but it is the place where I chose to put down roots. With Fargo's strong sense of resiliency and community, I would like to appeal to you as your neighbor. As a daily rider commuting to work, college, and appointments, I argue that an increase in fare, paired with a decrease in route frequency, will negatively impact ridership with a long-term decrease m revenue.

I understand that the reason for the proposal is economic-based. If prices have not been updated over the past ten years, it is time for a change. However, transit systems are particularly vulnerable to changes in ridership, especially with increased fares. According to the American Public Transportation Association, a 10% fare increase results in a 4% decrease in ridership for large cities and 8% in small cities within the US. Smailer cities have populations ranging from 50,000 to 100,00 people, and Fargo has a population of 120,000 according to the 2020 census, not including Moorhead and the greater area. With Fargo being somewhere in the middle and considering the proposed 33% price increase, 18% of current ridership is expected to decrease according to APTA. This is considering the price increase, and no additional variables to the current ride schedule.

Continuing to review the current proposal from MATBUS, three of the routes are going to be negatively impacted. Route 16 will cease to run, while routes 13 and 14 will decrease their frequency from 30 minutes to an hour. Decreasing frequency of routes negatively impacts ridership. Studies show that infrequent routes lose 7% or more of ridership per line for larger cities within the US, and 13% or more from smaller cities. With the proposed changes, a minimum of 10% of those two rides and all of route 16 will be eliminated. I don't have the time today to dig into each route's positive impacts on the Fargo Transit culture; however, it should be said that many people use these routes, and a delayed bus route is a bus in use.

There is a relationship of positive externality in pick-up frequency. More frequent times mean more opportunities to catch the bus. There are many vehicle owners who use MATBUS so they can save on gas, travel safely in the winter, and worry less about parking in downtown Fargo. I've met doctors, students, the elderly, and young families who all use the MATBUS transit system to travel through Fargo. If route times are decreased, then the many people who rely on the current transit schedule may need to consider alternate methods of travel because the system will become too inconvenient to use.

Fare increases and route decreases at the same time have historically led to a negative spiral for transit systems. A temporary increase in revenue will occur directly after the fare increase. However, the short-term gains have historically been lost within 6 months, as riders seek, find, and change their methods of travel, resulting in a no-win situation for anyone involved. The proposed changes with historical rider losses, 25%- 30% ofriders will leave the MATBUS ecosystem for a 33% price increase. Let's do the math:

In 2017, 1.4 million individual rides occurred at \$1.50. For ease, we will not be looking at the decreased fare options. That's 2.1 million dollars in revenue from people riding the bus. With just the price increase causing 18% of riders to drop, and the route frequency decreasing ridership by 2%, that's a 20% decrease in total ridership based on historical values. That makes 1.12 million riders at \$2 a ride, making 2.24 million dollars a year. That's a 6% increase in revenue, not profit, at the historical average. If the loss of ridership is any greater than 20%, the increase in revenue evaporates. MATBUS cannot afford that. I don't know if the negative spiral is the goal; however, I must state the obvious: we have been in a downward spiral for the past 10 years. The pandemic caused ridership to crash even further from 1. 7 million people in 201 7 to 800 thousand in 2022.

Recently, the number of riders has been recovering by a percentage of people who see the bus as a safe, alternate, and economic method of travel. I've seen more people at bus stations, bus stops, and on the buses themselves within the past 6 months than in 2024. Based on those numbers above, you will turn a small percentage of a profit at the maximum after 6-12 months.

Fargo is not just a metropolitan area, but a community with care and compassion. Personally, I have built a community within this transit system, and I know I am not the only one. I ask that you keep in mind the lasting impacts these changes will have on our neighborhoods. I ask you to consider that temporary returns in value are nothing compared to a strong network of connected individuals who are satisfied with the services being provided. Satisfied riders are riders who return. Riders who return are riders who consistently give back to good service and great systems. If it takes me over two hours to get from place to place, I will be required to seek other means of transportation, and I am not the only one. The people may not be able to directly vote about when the MATBUS services are running or how much the service costs; however, the people will vote with their time, their patience, and most importantly, their wallets.

As a rider of the matbus system, I cannot democratically vote on what and when bus routes are available. With upcoming changes causing a decrease in bus availability, current consumers will be forced to vote with their wallets. I am deeply concerned for the people for where other options are not available. I see women from our local shelters using the bus. I see people who are struggling with their jobs and with their homes. I see young people using the transit to safely traverse the community. One of the changes is to no longer use West Acres as a transit hub, but Walmart. The Walmart stop is essentially the middle of traffic, and does not have an enclosed and heated space like West Acres. When building and maintaining a community, you have to make sacrifices. I recognize this. Is the Fargo City Commission sacrificing a life-line in the community for those who need it, over revenue? Is that where priorities lie? Is it income and the everchanging dollar, or the people who live and breathe in the same neighborhoods as you?

Yet there is hope. Not all transit system changes are negative, even among the proposals here. In Spokane, Washington, limited increases in route frequency increased ridership by at least 13.4%. The Spokane Transit Authority added the Bus Rapid Transit line, connecting the downtown and university areas with a faster route. That one route alone brought nearly a million rides to the system in one year. When transit systems increase lines, riders return. Small investments in city transit transform into massive returns that are long-term and resilient to changes. Decreasing routes and increasing fares may grant a surface level response in revenue. The long-term effects can devastate a system to the point of no return. Transit is a service for the public good, and positively impacts people in many ways.
