1a. MEETING CALLED TO ORDER, WELCOME, AND INTRODUCTIONS, convened

The meeting was called to order at 4:00 pm, on April 16, 2020 by Chair Olson, noting a guorum was present. Introductions were made.

3a. Public Comment Opportunity

No public comments were made or received.

3b. 2019-2020 UPWP Amendment #6

Ms. Gray presented amendment #6 to the 2019-2020 Unified Planning Work Program (UPWP). The Veterans Boulevard Corridor Extension Study was originally budgeted for \$150,000, but after consideration and discussion of the study area, other study area complexities, and the need for the project to relate to ongoing studies currently being completed by local jurisdictions, an updated budget of \$180,000 is suggested for the study. This is a total addition of \$30,000 to the overall budget, which Metro COG can accommodate, but will likely require further review by NDDOT and FHWA, as the change puts the cumulative total of all of our amendments over the maximum threshold of 10%. Both Fargo and Horace have consented to the budgetary increase to their respective jurisdictional local match.

MOTION: Approve 2019-2020 UPWP Amendment #6 to add \$30,000 to the Veterans Boulevard Corridor Extension Study.

Mr. Gunkelman moved, seconded by Mr. Breitling.

MOTION, passed. 13-0

Motion carried unanimously.

3c. Veterans Boulevard Corridor Extension Study Consultant Selection

Mr. Farnsworth presented KLJ (SRF Consulting as subconsultant) as the topranked consulting firm for the Veterans Boulevard Corridor Extension Study. The sealed cost proposal provided a budget of \$180,000.

MOTION: Approve Metro COG entering into contract with KLJ for the Veterans Boulevard Corridor Extension Study.

Mr. Grindberg moved, seconded by Ms. Watson Curry.

MOTION, passed. 13-0

Motion carried unanimously.

3d. FTA Section 5310/5339 ND Transit Grant Application

Mr. Farnsworth presented the FTA ND 5310 (Transit Projects for mobility)/5339 (Transit projects for Capital Purchases) grant applications. The City of Fargo applied for a Mobility Transit Manager (\$103,000) for the 5310 Grant, and the purchase of six informational kiosks (\$210,000), and Miscellaneous Equipment purchase for the MTC – garage door replacement, hoist and tool upgrades (\$300,000) for the 5339 Grant.

Chair Olson asked if the projects need to be vetted through Metro COG. Mr. Farnsworth and Ms. Gray answered yes, as the NDDOT prefers having local government acknowledgement and approval.

MOTION: Approval of the FTA Section 5310 and 5339 Transit Grant Applications as discussed.

Mr. Hendrickson moved, seconded by Mr. Breitling.

MOTION, passed. 13-0

Motion carried unanimously.

3e. Dynamic Traffic Assignment Model – ATAC Proposed Scope of Work

Ms. Gray presented Addendum #5 to the Master Agreement with ATAC. The Dynamic Traffic Assignment model was budgeted and programmed into the 2019-2020 UPWP, with the budget set for \$30,000. ATAC provided the scope of work that was recommended for approval by the TTC at their April 9 meeting.

MOTION: Approve the Dynamic Traffic Assignment model scope of work as proposed by ATAC and Master Agreement Addendum #5.

Mr. Strand moved, seconded by Mr. Judd.

MOTION, passed. 13-0

Motion carried unanimously.

3f. Electronic Voting Policy and Procedure

Ms. Gray asked the board if any of their respective jurisdictions had any policies or procedures in place for electronic voting (Survey Monkey, DoodlePoll, e-mail, etc). During times when there is little need for a meeting, such as last summer when NDDOT needed a TIP amendment acted upon on short notice, it would be advantageous to have a procedure in place for electronic voting.

4. Additional Business

Ms. Gray informed the board that Metro COG staff member Anna Pierce had her baby on March 26, 2020.

Mr. Breitling asked how he can contact Metro COG Executive Assistant, Savanna Leach or other staff during the time when the office is closed. Re: 2020-2023 Transportation Improvement Program (TIP) Amendment #3

The Fargo-Moorhead Metropolitan Council of Governments (Metro COG) held a public hearing at the Metro COG Conference Room – 1 2nd Street North, Suite 232, in Fargo, North Dakota on Thursday, April 9, 2020 at 10:00 a.m. to consider public comments regarding a proposed amendment to the 2020-2023 Transportation Improvement Program (TIP) for the FM Metropolitan Area. Due to the COVID-19 Pandemic and resulting Stay at Home Order for Minnesotans, the final information regarding the grant award was not compiled prior to the initial public hearing, and the Transportation Technical Committee (TTC) continued the public hearing to the May TTC meeting, on Thursday, May 14, 2020 at 10:00 a.m.

The proposed amendment to the 2020-2023 TIP reflects a new rural transit grant award through the Minnesota Department of Transportation (MnDOT) and Federal Transit Administration (FTA).

A public notice was published in the Forum of Fargo-Moorhead on Monday, March 30, 2020, advertising the public hearing and detailing public comment information such as where to send written comments regarding the proposed amendment. It was advertised that public comments would be accepted until 12:00 p.m. (noon) on Thursday, April 16, 2020, however as part of the continuation of the hearing to the May TTC meeting, the deadline for comment was extended until Thursday, May 21, 2020. As of the writing of this memo, no comments have been received.

The final information for the proposed amendment to the 2020-2023 TIP is as follows:

 Addition of Project 8203001: West Central Communities Action, Inc., Regional Transportation Coordinating Council for Region 4 (R4RTCC) operating activities. The total project cost is \$56,000 of which \$44,800 is funded by Federal Section 5310 funds, \$5,600 state funds, and \$5,600 through local funds.

The Fargo-Moorhead Metropolitan Council of Governments (Metro COG) held a virtual public hearing on Thursday, May 14, 2020 at 10:00 a.m. to consider public comments regarding a proposed amendment to the 2020-2023 Transportation Improvement Program (TIP) for the FM Metropolitan Area. The proposed amendment to the 2020-2023 TIP reflects new federally funded projects within the Metropolitan Planning Area (MPA).

A public notice was published in the Forum of Fargo-Moorhead on Tuesday, May 5, 2020, advertising the public hearing and detailing public comment information such as where to send written comments regarding the proposed amendment, and how to participate virtually. The public notice advertised that public comments will be accepted until 12:00 p.m. (noon) on Thursday, May 21, 2020. As of the writing of this memo, no comments have been received.

The proposed amendment to the 2020-2023 TIP is as follows:

- Addition of Project 3204001: City of West Fargo I-94 and Veteran's Boulevard (9th St) structure rehabilitation project (2020*). The total project cost is \$482,000 of which \$390,082 is funded by Federal Surface Transportation Block Grant Program Urban (STBGP-U) funds, and \$91,918 through local funds. *The project is listed as a pending project.
- Addition of Project 8204002: MnDOT D4 Districtwide safety improvement project (2021). The total project cost is \$534,693 of which \$481,224 is funded by federal Highway Safety Improvement Program (HSIP) funds, and \$53,469 through state funds.

The purpose of this study, extending from 13th Avenue E to 12th Avenue NE, is to develop and refine transportation alternatives that take into account the needs of all users and may be considered for future implementation projects by the City. The need to identify future transportation alternatives along the corridor is driven by several factors including: aging infrastructure, increasing traffic volumes, safety issues, and future development of undeveloped land adjacent to the corridor.

Re: Horace Comprehensive and Transportation Plan

In December 2018, Metro COG contracted with Stantec for the completion of the Horace Comprehensive and Transportation Plan – an update to the City's 2007 comprehensive plan. The plan can be viewed on Metro COG's website:

http://www.fmmetrocog.org/projects-rfps/rfp-horace-comprehensive-transportationplan

The purpose of the new plan is to help the City of Horace prepare for anticipated population and employment growth and ensure that new development is compatible with the community's vision and guiding principles. Impacts such as regional economic and demographic changes, groundbreaking of two new schools, a potential I-29 interchange at 76th Avenue, and the current alignment of the FM Area Diversion Project were addressed as part of the planning process.

The Horace Comprehensive and Transportation Plan places an emphasis on transportation, economic development, and land use strategies that balance the density and style of future developments. The plan is aimed at benefitting existing and future Horace residents from a quality of life and economic standpoint by providing for a wider range of housing choices and a land use mixture that helps balance tax revenues with the costs of public service and infrastructure. The future land use map provides a long-term vision for how and where the city can be expected to grow and change, with guidance and flexibility to accommodate new opportunities and direct public investments in infrastructure.

The plan utilizes small area plans to provide a higher level of design and character in areas anticipated to attract the most new development in the coming years. These plans show the general character and scale of development with anticipated land uses, street connections, and parks and open space. The small area plans seek to establish an identifiable character in contrast to typical new suburban developments, while highlighting recognized development constraints and opportunities.

Transportation and connectivity are addressed extensively in the plan, acknowledging recently completed plans and expected transportation system improvements. Transportation needs analyzed include: existing and future roadway network connectivity both within the city and to surrounding areas, proposed functional classifications, proposed street typologies, access spacing and intersection control for arterial and collector roadways, multimodal networks, and complete streets policies.

At their May 14, 2020 meeting, the TTC recommended Policy Board approval.

Re: US 10/75 Corridor Study – Draft Final Plan Adoption and Online Open House

The US 10/75 Corridor Study was initiated at the request of the Minnesota Department of Transportation in preparation for a full reconstruction of US Highway 10 and US Highway 75 through Moorhead due to deteriorating pavement conditions. Metro COG incorporated this planning effort into its work program in 2018, released an RFP, carried out a qualifications-based selection process, and subsequently contracted with SRF Consulting Group to complete the study.

The report focuses on key issues with the corridor such as:

- The lack of bicycle and pedestrian amenities along certain corridor segments despite the college campus and downtown context of the corridors,
- Safety concerns at intersections and peculiar roadway alignments along the corridor,
- How to address the former weigh station area on US 10 as well as enhance Moorhead's gateway image, and
- Roadway treatments that could provide an impetus for redevelopment in Downtown Moorhead.

The Final Study provides an analysis of existing and future conditions. Corridor alternatives are provided that will guide MnDOT and the City of Moorhead as they move into final design. The process has allowed MnDOT, the City of Moorhead, Moorhead Downtown Inc. and Metro COG to collaborate on creating a vision for the roadway segments included in MnDOT's upcoming reconstruction project. The effort was guided by a Study Review Committee (SRC) consisting of representatives from MnDOT District 4, City of Moorhead, Downtown Moorhead Inc, Minnesota State University Moorhead (MSUM), and Metro COG.

The planning process included multiple public outreach efforts designed to both inform and gain input from the general public and corridor stakeholders. As of the writing of this memo, the last public engagement effort is taking place via an online public meeting.

Metro COG has promoted public participation through a mass email to our broad mailing list of approximately 800 people, posts on Metro COG's and the City of Moorhead's Facebook pages, MnDOT District 4 website, and a press release sent to local FM Area news media outlets. The consultant made a presentation to the Moorhead City Council on Monday, May 11, 2020 where the Council was updated on the final draft report and the public input received from the ongoing online public meeting. The Council unanimously acted to approve a resolution of support for the US 10/75 Corridor Study.

At their May 14th meeting, the Transportation Technical Committee recommended approval of the Draft Final US 10/75 Corridor Study with no changes requested.

Metro COG is asking that the Policy Board members review the plan, forward any comments or questions to me, and approve the Draft Final US 10/75 Corridor Study. Upon approval, the consultant will finalize the plan by incorporating any changes requested by the Policy Board and print the final plan.

In preparation for local 2021 budget work, a draft 2021 work program and budget has been completed. The estimates of local match from Metro COG's partner jurisdictions is based on a combination of the following:

- 1. **Anticipated revenues**, most of which consist of Consolidated Planning Grant (CPG) funds from the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) these funds require a 20 percent local match.
- The approved dues formula, which is a breakdown of the 20 percent local match requirement based on population percentages of local jurisdictions as of the 2010 census,

3. Overhead and operations

- a. Items such as rent, supplies, communications, technology, travel, training, dues and subscriptions,
- b. Agency wages plus benefits (loaded wages)

4. Contracted Projects

- a. Shared projects projects that pertain to all jurisdictions and, in most cases, relate to required elements of all metropolitan planning programs, and
- b. Jurisdiction-specific projects studies or plans that relate specifically to only one jurisdiction or in some cases multiple jurisdictions or entities.

The budget was initially estimated by assuming a one percent (1%) increase in Federal funds. The risk in underestimating these funds is that the required 20 percent local match is also underestimated. The risk in overestimating the Federal funds is that we include contracted projects that may end up being infeasible with the amounts budgeted. Between the preparation of information for the May 6th Executive Committee meeting and the May 14th TTC meeting, I received more definitive information about the anticipated level of Federal funding from NDDOT. The CPG amount for 2021 will be \$1,277,061. This is \$67,482 higher than I had originally estimated, resulting in a local funding match requirement increase of \$16,870.

In the table on the following page, an updated local match amount estimated for each jurisdiction is shown. The amounts are based on a draft work program. Funding in the "other" category is expected to come from entities such as NDDOT or MnDOT. In the past, the "other" category has also included entities such as the FM Diversion Authority. At this time, neither MnDOT nor NDDOT has finalized the amount of participation they will have in funding the interstate operations study, but MnDOT has requested a budget amount of \$80,000. For budgeting purposes, I have estimated \$80,000 from MnDOT and \$40,000 from NDDOT. NDDOT's amount would be in the form

of half of the local match. However, I have asked NDDOT to provide a higher level of match on this project, since it addresses the interstate highway system. If they come through on this request, this has the potential to reduce the overall amount of local match required.

Metro COG is back to working with a more typical annual amount of Federal funding after obligating unused Federal funds from 2014. Projects that required the use of those funds were amended into the 2018 UPWP and have been underway for over a year. Some have recently been completed.

Details of the proposed 2021 budget are attached, as follows. Information for 2022 is also provided, since Metro COG prepares a two-year work program:

- Attachment 1 Draft 2021 Operations (Loaded Wages + Overhead)
- Attachment 2 Draft 2021 Projects

The 2021-2022 Unified Planning Work Program (UPWP) will be brought to the Policy Board for final approval in September or October.

The proposed 2021 and 2022 work program and estimated budget was presented to the Executive Committee at their May 6th meeting, and will be discussed with them again on May 20th. The Executive Committee requested historical information regarding the local match amounts for each jurisdiction. This information is provided in **Attachment 5**, **Comparison of Proposed 2021 Local Match Amounts with Prior Three Years (2018-2020)**. Data is provided as far back as 2018. Prior to that, Metro COG was not fully utilizing its CPG funds, which led to unused funds dating back to 2014 (the grant was never opened, because Metro COG hadn't obligated the funds). Therefore, the data prior to 2018 does not have a direct relationship to the amount of Federal funding our metropolitan area receives for transportation planning purposes.

At their May 14th meeting, the Transportation Technical Committee (TTC) reviewed this information and asked for an opportunity to discuss it again at their June meeting. Since the TTC requested the opportunity to further digest this information, the Policy Board may wish to also delay action on this item. In the meantime, I will be coordinating with the staff from each jurisdiction about the contracted projects included in the draft work program.

Requested Action: Approval of the estimated 2021 budget – OR – delay action until the June meeting, pending a recommendation from the TTC.
