Please consider this memorandum as a formal request from the Fargo-Moorhead Metropolitan Council of Governments (Metro COG) to modify the projects below in the 2020-2023 Transportation Improvement Program (TIP). No formal MPO action is required for Administrative Adjustments; this memo is to summarize the changes made to the Metro COG 2020-2023 TIP. The attached project table shows the updated projects included in this Administrative Adjustment.

- 1. Adjustment of Moorhead Transit Project 5170005: Moorhead Transit capital purchase of one (1) <30 ft. replacement bus and bus related equipment (replaces unit #1231). Project year moved from 2020 to 2021, total project cost increased from \$87,000 to \$91,000 or an increase of 4.6%. Federal Surface Transportation Block Grant Program (STBGP) funds increased from \$69,600 to \$72,800 or an increase of 4.6%. New State funding match of \$9,100 or 10% of the total cost. City of Moorhead funding match decreased from \$17,400 (20% of the total project cost originally) to \$9,100 or 10% of the total project cost.
- 2. Adjustment of Moorhead Transit Project 5170006: Moorhead Transit capital purchase of one (1) <30 ft. replacement bus and bus related equipment (replaces unit #1232). Project year moved from 2020 to 2021, total project cost increased from \$87,000 to \$91,000 or an increase of 4.6%. Federal Surface Transportation Block Grant Program (STBGP) funds increased from \$69,600 to \$72,800 or an increase of 4.6%. New State funding match of \$9,100 or 10% of the total cost. City of Moorhead funding match decreased from \$17,400 (20% of the total project cost originally) to \$9,100 or 10% of the total project cost.
- 3. Adjustment of Fargo Transit Project 4162672: Fargo Transit operating assistance, paratransit operating assistance funded as capital, and preventative maintenance. Total project cost increased from \$4,288,000 to \$4,803,891 or an increase of 12%. Federal Transit Administration (FTA) Section 5307 funds increased from \$2,787,000 to \$2,807,164 or an increase of 0.7%. City of Fargo funding match increased from \$1,501,000 (35% of the total project cost originally) to \$1,996,727 or 42% of the total project cost.

This Administrative Adjustment is pursuant to Section 11 of the Metro COG 2020-2023 TIP which states the following applicable reasons to perform an administrative adjustment:

Change in TIP year

- Increase or decrease in cost estimate that meets FHWA/FTA administrative adjustment thresholds
  - a. FHWA threshold is not applicable, as no formal amendment is needed for a change in cost if the project is under \$1,000,000
  - b. FTA change in project cost threshold for formal amendment is 20%
- The addition of state funds to a project in the TIP, which is not regionally significant.
