Amendment #4 to the 2020-2023 Transportation Improvement Program (TIP) for the Fargo-Moorhead Metropolitan Area

The Fargo-Moorhead Metropolitan Council of Governments (Metro COG) held a virtual public hearing at the Case Plaza Conference Room at One 2nd Street North, Suite 232, in Fargo, North Dakota on Thursday, May 14, 2020 at 10:00 a.m. to consider public comments on the proposed Amendment #4 to the 2020-2023 TIP. The public comment period officially ended at 12:00 p.m. (noon) on Thursday, May 21, 2020, prior to Policy Board action on the Amendment #4 to the 2020-2023 TIP. Amendment #4 to the 2020-2023 TIP is described below:

Addition of Project 3204001: City of West Fargo I-94 and Veteran's Boulevard (9th St) structure rehabilitation project (2020*). The total project cost is \$482,000 of which \$390,082 is funded by Federal Surface Transportation Block Grant Program – Urban (STBGP-U) funds, and \$91,918 through local funds. *The project is listed as a pending project.

Addition of Project 8204002: MnDOT D4 Districtwide safety improvement project (2021). The total project cost is \$534,693 of which \$481,224 is funded by federal Highway Safety Improvement Program (HSIP) funds, and \$53,469 through state funds.

The public was notified on Monday, May 5, 2020 of the proposed 2020-2023 TIP amendment as per the adopted Metro COG Public Participation Plan (PPP). Public comments were accepted until 12:00 p.m. (noon) May 21, 2020. No public comments were received by Metro COG either verbally during the public hearing nor by written statement.

The Policy Board approved the described amendment at their May 21, 2020 meeting. The updated TIP project sheet reflecting the amendment is also attached.
